Important Information for all Pilgrims Please read this information before signing and returning your booking and deposit.

The fare per person is £685*. Your fare is inclusive of direct flights from Belfast to Lourdes (including 1 x 20kg checkin bag and 1 x small cabin bag), transfers from and to Lourdes Airport, courier services, 5 nights shared full-board accommodation, airport taxes and charges and complementary travel insurance (conditions apply*). You are reminded that Joe Walsh Tours reserves the right to levy a surcharge on each individual fare, the Tour Operator will notify you in writing of any such increase.

CITY TAX: All pilgrims aged 18 or over will be subject to a local government tax (currently €2.10 per person per night.) This tax will be charged directly by your hotel and is payable on arrival at the hotel reception.

FINANCIAL PROTECTION: This tour is operated by Northern Star Travel Ltd. Flight inclusive packages originating in the UK are financially protected under the ATOL 11313 held by Northern Star Travel Ltd in compliance with the ATOL scheme administered by the Civil Aviation Authority

REGULATION (EC) 261/2004: This regulation establishes common rules on compensation and assistance to passengers in the event of denied boarding, cancellation or long delay of flights. The obligations that the regulation creates rests with the operating carrier who performs or intends to perform a flight. Any compensation that may be due to passengers in case of a delay must be claimed exclusively by the passenger and directly to the airline and not Joe Walsh Tours or the Diocese of Down & Connor. The regulation has been incorporated under UK law by the Air Passenger Rights and Air Travel Organisers' Licencing (Amendment)(EU Exit) Regulations 2019.

COVID-19: The Pilgrimage Committee and Joe Walsh Tours are committed to the health and wellbeing of all our pilgrims. We will endeavour to provide guidance in relation to travel and health and safety protocols in place at home and abroad at the time of travel. We are not able to submit details and make declarations to government or other civic authorities on behalf of pilgrims. It is your responsibility to ensure you comply with all travel requirements in place at the time of travel. Failure to comply with travel requirements may result in you being denied boarding or entry to the destination or denied access to facilities and activities while in Lourdes.

Due to the prevailing circumstances, please note that there will be no medical or nursing support available from the Pilgrimage Committee and that the Youth Team will be limited in number. Pilgrims must be able to travel independently or be accompanied by someone who can provide for all their care needs. In the event of illness pilgrims will be directed to the locally available medical services.
